AND

MAHIDOL UNIVERSITY, THAILAND

THIS SUPPLEMENTARY MEMORANDUM OF UNDERSTANDING is made on the 26 day of July 2010

Between

UNIVERSITI KEBANGSAAN MALAYSIA an institution of higher learning established and incorporated under the Universities and University Colleges Act 1971 (hereinafter referred to as "**UKM**") and having its address at 43600 UKM Bangi, Selangor Darul Ehsan, MALAYSIA, of the one part,

And

MAHIDOL UNIVERSITY, an institution of higher learning (hereinafter referred to as "**MU**") and having its address is at 272 Rama VI Rd., Ratchathewi, Bangkok 10400 THAILAND of the other part.

(Both **UKM** and **MU** shall be collectively referred as "**Parties**" and individually as "**Party**").

WHEREAS

- A. On 23rd November 2009, the Parties executed a Memorandum of Understanding on research and academic collaboration (hereinafter referred to as "**First Memorandum of Understanding**").
- B. Following discussions, both Parties have now agreed to add academic and research activities between the Integrated Water Resources Management Research Group (IWRM RG), Regional Sustainable Development Research Niche of **UKM**, with the Faculty of Environment and Resource Studies (FERS) of **MU**, to be read together with the provisions of the First Memorandum of Understanding.
- C. The Parties hereto have agreed to execute this Supplementary Memorandum of Understanding to reflect the additional provisions agreed to between the Parties, which are subject to the terms and conditions as hereinafter spelt out in this Supplementary Memorandum of Understanding.

NOW IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. This Supplementary Memorandum of Understanding is an addition to the First Memorandum of Understanding. From the date of this Supplementary Memorandum of Understanding, the provisions of the First Memorandum of Understanding, except as amended and supplemented by this Supplementary Memorandum of Understanding, will continue to be in full force and effect. Therefore, the First Memorandum of Understanding and this Supplementary Memorandum of Understanding are to read and be construed as one instrument.
2. Further to discussions held, the Parties hereby agree to insert a new list of activities to be undertaken between the Integrated Water Resources Management Research Group (IWRM RG), Regional Sustainable Development Research Niche of UKM, with the Faculty of Environment and Resource Studies (FERS) of MU, being attached to this Supplemental Memorandum of Understanding and shall read as follows:




